# **Rep. McBath's July 2025 Federal Grants Newsletter**

## **Department of Education**

### **Office of Special Education and Rehabilitative Services (OSERS): Rehabilitation Services Administration (RSA): Parent Information and Training Program: Technical Assistance for Parent Training and Information Centers**

- Closing Date: **July 18, 2025**
- Description: The purpose of the Parent Information and Training (PTI) centers is to meet the information and training needs of individuals with disabilities and their families, so that individuals with disabilities can achieve their employment and independent living goals. The Department intends to fund eight Regional Parent Information and Training Centers (PTIs) (Assistance Listing Number (ALN) 84.235F) and one National PTI Technical Assistance (TA) Center (ALN 84.235G) as part of this program administered by the Rehabilitation Services Administration (RSA).
- Eligibility: Private nonprofit organizations that meet the requirements in section 303(c)(4) of the Rehabilitation Act of 1973, as amended (Rehabilitation Act). An applicant must—(a) Include information demonstrating the capacity and expertise of the organization to—(i) Coordinate training and information activities with Centers for Independent Living;(ii) Coordinate and work closely with PTIs established pursuant to section 671 of IDEA, the Community Parent Resource Centers pursuant to section 672 of IDEA, and the eligible entities receiving awards under section 673 of IDEA; and(iii) Effectively conduct the training and information activities authorized in section 303(c) of the Rehabilitation Act;(b) Be governed by a board of directors that—(i) Includes professionals in the vocational rehabilitation (VR) field; and on which a majority of the members are individuals with disabilities or the parents, family members, guardians, advocates, or authorized representatives of the individuals (hereafter collectively referred to as “individuals with disabilities and their families”); or(ii) Has a membership that represents the interests of individuals with

disabilities; and establishes a special governing committee to operate a training and information program that includes professionals in the VR field and on which a majority of the members are individuals with disabilities and their families; and may include representatives from special education and other public and private agencies on the board, as appropriate; and(c) Serve, and demonstrate the capacity for serving, individuals with a full range of disabilities, and the parents, family members, guardians, advocates, or authorized representatives of the individuals.

## **Department of Health and Human Services**

### **[Tobacco Regulatory Science Small Grant Program for New Investigators | R03 Clinical Trial Optional](#)**

- Closing Date: **July 14, 2026**
- Description: This Notice of Funding Opportunity (NOFO) aims to support new biomedical, behavioral, and social science investigators who are in the early stages of establishing independent careers in tobacco regulatory research. The R03 grant mechanism supports different types of projects, including pilot and feasibility studies, secondary analysis of existing data, small, self-contained research projects, development of research methodology, and development of new research technology. Applicants are encouraged to conduct projects that ultimately have the potential to inform regulations on tobacco product manufacturing, distribution, and marketing. Research projects must address one or more High-Priority Research Topic(s) related to the regulatory authority of the Food and Drug Administration (FDA) Center for Tobacco Products (CTP) as mandated by the Family Smoking Prevention and Tobacco Control Act (FSPTCA), Public Law 111-31. The awards under this NOFO will be administered by NIH using funds made available through FDA CTP and the FSPTCA. Research results from this NOFO are expected to generate findings and data directly relevant to informing the FDA's regulation of the manufacture, distribution, and marketing of tobacco products to protect public health.

- Eligibility: Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education, State governments, Native American tribal governments (Federally recognized), Native American tribal organizations (other than Federally recognized tribal governments), Independent school districts, Private institutions of higher education, For profit organizations other than small businesses, Small businesses, County governments, Special district governments, Public housing authorities/Indian housing authorities, City or township governments, Public and State controlled institutions of higher education, Nonprofits that do not have a 501(c)(3) status with the IRS, other than institutions of higher education

## **Department of Housing and Urban Development**

### **Addressing the Housing Affordability Crisis Research Grant Program**

- Closing Date: **July 24, 2025 Electronically submitted applications must be submitted no later than 11:59 p.m., ET, on the listed application due date.**
- Description: HUD/PD&Rs funding opportunity titled Addressing the Housing Affordability Crisis Research Grant Program will provide competitive awards to: (1) fund quality research that contributes to knowledge about the housing affordability crisis in the United States; and (2) generate actionable insights and evidence that can inform policy decisions to address the housing affordability crisis in the short-term. Through this funding opportunity, PD&R will fund research projects that contribute to one of the five eligible research categories, including: 1) Government-induced Demand and Housing Affordability, 2) Immigration and Housing Affordability, 3) The Financialization of Housing and Housing Affordability, 4) Economic Opportunity Cost and Housing Affordability, and 5) Opportunity Zones identified in Section III.G. Eligible applicants for this funding opportunity include institutions of higher education, nonprofit, and for-profit institutions. Awards made under this NOFO will be cooperative agreements and, therefore, awardees should anticipate substantial involvement by subject matter experts within PD&R in the execution of funded projects.

- Eligibility: Public and State controlled institutions of higher education, Small businesses, Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education, For profit organizations other than small businesses, Nonprofits that do not have a 501(c)(3) status with the IRS, other than institutions of higher education, Private institutions of higher education

## **Department of Justice**

### **OVW Fiscal Year 2025 Rural Domestic Violence, Dating Violence, Sexual Assault, and Stalking Program**

- Closing Date: **July 8, 2025**
- Description: The Rural Domestic Violence, Dating Violence, Sexual Assault, and Stalking Program (Rural Program) enhances the safety of rural victims of sexual assault, domestic violence, dating violence, and stalking by supporting projects uniquely designed to address and prevent these crimes in rural areas. This program supports cooperative efforts among law enforcement officers, prosecutors, victim service providers, and other related parties to investigate and prosecute sexual assault, domestic violence, dating violence, and stalking; treatment, advocacy, counseling, legal assistance, or other victim services for victims in rural communities; or programs addressing sexual assault. Eligible entities applicants are states and territories, Indian Tribes, local governments, and nonprofit (public or private) entities, including Tribal nonprofit organizations.
- Eligibility: Private institutions of higher education, City or township governments, Others (see text field entitled "Additional Information on Eligibility" for clarification), Native American tribal governments (Federally recognized), Native American tribal organizations (other than Federally recognized tribal governments), Nonprofits that do not have a 501(c)(3) status with the IRS, other than institutions of higher education, Public housing authorities/Indian housing authorities, State governments, County governments, Nonprofits having a 501(c)(3) status with the IRS, other than

institutions of higher education, Public and State controlled institutions of higher education.

**OVW Fiscal Year 2025 Demonstration Program on Trauma-Informed, Victim Centered Training for Law Enforcement on Domestic Violence, Dating Violence, Sexual Assault, and Stalking (Abby Honold) Program**

- Closing Date: **July 18, 2025**
- Description: The Demonstration Program on Trauma-Informed, Victim Centered Training for Law Enforcement on Domestic Violence, Dating Violence, Sexual Assault, and Stalking (Abby Honold Program) (Assistance Listing Number #16.058) supports efforts to improve law enforcement's response to allegations of domestic violence, dating violence, sexual assault, and stalking from the time of a victim's initial report throughout the entire investigation, and to promote the efforts of law enforcement in improving the response to these crimes. Note that in Fiscal Year (FY) 2025, the Abby Honold Program will only support projects addressing responses to allegations of sexual assault. The Abby Honold Program awards grants to law enforcement agencies to train officers to conduct trauma-informed and victim-centered investigations, with the goal of incorporating trauma-informed techniques designed to prevent re-traumatization of the victim and to increase communication between victims and law enforcement as well as stakeholders in a coordinated community response. This program's purpose is also to evaluate the effectiveness of the training.
- Eligibility: State governments, special district governments, city or township governments, native american tribal governments (federally recongized), county governments, others such as State, territorial, local, and/or Tribal law enforcement agencies that investigate crimes involving sexual assault

**OVW Fiscal Year 2025 Grants to Enhance Community-based Services for Survivors of Domestic Violence, Dating Violence, Sexual Assault, and Stalking Program**

- Closing Date: **August 1, 2025**
- Description: The Grants to Enhance Community-based Services for Survivors of Domestic Violence, Dating Violence, Sexual Assault, and Stalking Program (CSSP) supports (1) the maintenance and replication of domestic violence, dating violence, sexual assault, and stalking services in community-based programs that offer culturally specific services and other resources; and (2) the development of innovative community-based programming that improves access to services and resources for victims who face obstacles to using traditional services. Eligible entities are community-based organizations that aim to enhance access to services for all survivors of domestic violence, dating violence, sexual assault, and stalking in their communities and that have demonstrated expertise in serving victims or can partner with a program having such expertise.
- Eligibility: entities that are eligible to apply are: (1) Community-based organizations whose primary purpose is providing culturally specific services to victims of domestic violence, dating violence, sexual assault, and stalking; and (2) Community-based organizations whose primary purpose is providing culturally specific services who can partner with a program having demonstrated expertise in serving victims of domestic violence, dating violence, sexual assault, and stalking.

#### **OCW FY 2025 Local Law Enforcement Grants for Enforcement of Cybercrimes Program**

- Closing Date: **August 7, 2025**
- Description: The Local Law Enforcement Grants for Enforcement of Cybercrimes Program (Cybercrimes Enforcement Program) supports efforts by States, Indian Tribes, and units of local government to prevent, enforce, and prosecute cybercrimes against individuals with a focus on adult and young adult cybercrime victims. Cybercrimes against individuals are defined as criminal offenses that involve the use of a computer to harass, threaten, stalk, extort, coerce, cause fear to, or intimidate an individual, or without consent distribute intimate images of an adult, except that use of a computer need not be an element of the offense. (See 34 U.S.C. § 30107(a)(2)). Cybercrimes against individuals do not include the use of a computer to cause harm to a



commercial entity, government agency or nonnatural person. Note: The term computer includes a computer network and an interactive electronic device.

- Eligibility: State governments, Native American tribal governments (Federally recognized), County governments, City or township governments

## **Department of State**

### **Bureau of Counterterrorism Opportunity | Preventing Terrorism Recruitment of Youth Online**

- Closing Date: **August 7, 2025**
- Description: In 2024, teenagers accounted for up to two-thirds of ISIS-linked arrests in Europe, with children as young as 11 involved in recent terrorist plots. With governments becoming increasingly concerned about this evolving threat and the increasingly younger age of children being targeted, there is a need to effectively prevent the exploitation of social media and online gaming platforms for terrorist radicalization and recruitment. CT therefore seeks a proposal that not only diminishes the availability of terrorist content but also provides vulnerable communities with the resources to identify terrorist threats online.
- Eligibility: Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education

## **Department of Transportation**

### **FY2025 Commercial Driver's License Program Implementation (CDLPI)**

- Closing Date: **July 7, 2025**
- Description: The CDLPI program objective is to provide financial assistance to States and other eligible entities to carry out and improve the national CDL program. The national CDL program focuses on the concept that each driver has only one driving record and only one licensing document, commonly referred to as "One Driver — One License — One Record." Further, the national CDL program requires States to conduct knowledge and skills testing before issuing a Commercial Learner's Permit (CLP) and/or CDL; to maintain a complete and accurate driver history record (DHR) for



anyone who obtains a CLP and/or CDL; and to impose driver disqualifications, as required by the regulations.

- Eligibility: Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education, Private institutions of higher education, Public and State controlled institutions of higher education, City or township governments, Small businesses, Native American tribal governments (Federally recognized), For profit organizations other than small businesses, State governments, County governments

### **Competitive Funding Opportunity: Buses and Bus Facilities Program**

- Closing Date: **July 14, 2025**
- Description: The Federal Transit Administration (FTA) announces the availability of approximately \$398 million in competitive grants under the Buses and Bus Facilities Program to assist in the financing of buses and bus facilities capital projects, including replacing, rehabilitating, purchasing or leasing buses or related equipment, and rehabilitating, purchasing, constructing or leasing bus-related facilities. Synopses and full announcement will be posted on Grants.gov as opportunity FTA-2025-007-TPM-BUS. Proposals must be submitted electronically through Grants.gov website by 11:59 PM Eastern Time July 14th, 2025.
- Eligibility: City or township governments, Others (see text field entitled "Additional Information on Eligibility" for clarification), State governments, Native American tribal governments (Federally recognized), County governments. Eligible applicants for the Buses and Bus Facilities Program include designated recipients that allocate funds to fixed route bus operators, States (including territories and Washington D.C.) or local governmental entities that operate fixed route bus service, and Indian tribes. Eligible subrecipients include all otherwise eligible applicants and also private nonprofit organizations engaged in public transportation. Except for projects proposed by Indian tribes, all proposals for projects in rural (non-urbanized) areas must be submitted by a State, either individually or as a part of a statewide application.

### **FY 2023-2026 Bridge Investment Program, Large Bridge Project Grants**

- Closing Date: **August 1, 2025 FY 2023 and FY 2024 funds, applications must be submitted by 11:59 p.m. EST on 12/04/23. FY 2025 funds, applications must be submitted by 11:59 p.m. EDT on 08/01/24. FY 2026 funds, applications must be submitted by 11:59 p.m. EDT on 08/01/25.**
- Description: The purpose of this notice is to solicit applications for Large Bridge Project grants (a project with total eligible costs greater than \$100 million) for awards under the Bridge Investment Program (BIP). This notice establishes a “rolling application” process for Large Bridge Project applications by providing the schedule, requirements, and selection process for such projects for the remaining available amounts of BIP funding provided by the Infrastructure Investment and Jobs Act (IIJA) for FY 2023 through FY 2026, which total up to \$9.62 billion (see section B.1 for details for funds available for each fiscal year). The FHWA will solicit applications for the other two BIP project categories in a subsequent NOFO: (1) Planning and (2) Bridge Project (a project with total eligible costs not greater than \$100 million)
- Eligibility: County governments, City or township governments, State governments, Special district governments, Native American tribal governments (Federally recognized)

## **Department of Veterans Affairs**

### **[Legal Services for Homeless Veterans and Veterans At-Risk for Homelessness \(LSV-H\) Grant Program](#)**

- Closing Date: **July 7, 2025**
- Description: Ending and preventing homelessness among Veterans is a priority for VA. VA's Homeless Programs constitute the Nation's largest integrated network of homeless treatment and assistance services for Veterans. The LSV-H Grant Program's purpose is to award legal services grants to eligible public or non-profit private entities who will provide legal services to eligible Veterans who are homeless or at risk for homelessness. This NOFO will provide awards designed to address the needs identified in 38 C.F.R. § 79.20, including legal services related to housing; family law; income support; criminal defense; protective orders and other matters related to domestic or intimate partner violence; access to health care; requests to upgrade military discharge or dismissal; consumer law, such as financial services, debt collection, garnishments, usury, fraud, and financial

exploitation; employment law; and the top 10 unmet legal needs as enumerated on VA's annual Community Homelessness Assessment, Local Education and Networking Groups (CHALENG) survey for the grant award cycle.

- Eligibility: An eligible applicant is a public or nonprofit private entity as defined in 38 CFR part 79.10. Applicants must have the necessary technical and administrative abilities and resources to execute the program successfully.

#### **Staff Sergeant Fox Suicide Prevention Grant Program Funding Opportunity**

- Closing Date: **July 18, 2025**
- Description: The SSG Fox SPGP directs efforts to reduce Veteran suicide by awarding grants to community-based organizations to provide or coordinate the provision of primarily non-clinical suicide prevention services, including outreach and linkage to VA and community resources, to eligible individuals and their families. The SSG Fox SPGP furthers VA's public health approach to suicide prevention by combining community-based efforts with linkage to clinical care to prevent Veteran suicide for those inside and outside of VA health care. The goal of these grants is to reduce Veteran suicide risk by improving mental health status, well-being, financial stability, and social support for eligible individuals and their families.
- Eligibility: Eligible applicants are organizations that meet the definition of an eligible entity in section 201(q)(3) of the Commander John Scott Hannon Veterans Mental Health Care Improvement Act of 2019 (Hannon Act), codified at 38 U.S.C. § 1720F note. These may include incorporated private institutions or foundations for which no part of the net earnings inure to the benefit of any individual and that have a governing board responsible for the operation of the suicide prevention services provided under the SSG Fox SPGP; corporations wholly owned by incorporated private institutions or foundations meeting the requirements listed above; Indian tribes; community-based organizations that can effectively network with local civic organizations, regional health systems, and other settings where eligible individuals and their families are likely to have contact; and state or local governments.

## **National Endowment for the Arts**

### **Celebrating America250: Arts Projects Honoring the National Garden of American Heroes**

- Closing Date: **July 14, 2025**
- Description: The NEA will offer grants of \$25,000 each (no cost share required) for arts projects in any discipline that celebrate the contributions to American history of one or more of the national heroes listed in Executive Order 13978 of January 18, 2021. See full guidelines at <https://www.arts.gov/grants/national-garden-of-heroes>.
- Eligibility: County governments, Private institutions of higher education, Special district governments, Native American tribal organizations (other than Federally recognized tribal governments), Independent school districts, City or township governments, Native American tribal governments (Federally recognized), Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education, State governments, Public and State controlled institutions of higher education

## **National Endowment for the Humanities**

### **Rediscovering our Revolutionary Tradition**

- Closing Date: **September 4, 2025**
- Description: The National Endowment for the Humanities (NEH) Division of Preservation and Access is accepting applications for the Rediscovering Our Revolutionary Tradition program. The purpose of this program is to preserve and improve access to primary source materials that document the history of America's founding era and of American government in federal, state, and local contexts. Supported activities include conservation treatment and

rehousing, digitization and description, transcription and translation, and updating existing digital resources to ensure long-term public availability. This program is offered in honor of the 250th anniversary of the signing of the Declaration of Independence in 2026.

- Eligibility: Public and State controlled institutions of higher education, Native American tribal governments (Federally recognized), Private institutions of higher education, Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education, State governments, County governments, City or township governments, Special district governments
